- ☞ Deadline to submit entry form and photo(s), by person, mail, or email: **March 31, 2021**
 - ☞ Entrants must be 10 years of age or older
 - ☞ Entries must be the original artwork of the entrant, and cannot have been entered in a previous year of the Township's Upcycling Design Challenge
 - ☞ All submissions will be chosen by a jury of Langley Arts Council and Langley Centennial Museum staff
 - ☞ All artwork selected to exhibit must be ready to display, and must remain on display until the end of the exhibition
 - ☞ All artists will be informed of a decision on or before **April 9, 2021**
 - ☞ All work must be dropped off at the museum on **Saturday, April 17, 2021** between 10:00am and 2:00pm, unless other arrangements have been made with the Curator
